But if you fill up First Name as "Koh Lim" and Last Name as "Tan", then on the GRI Certificate, it will appear as "Koh Lim Tan". As such, please fill it up your name correctly from the start. Making changes adds to unnecessary administrative hurdles for GRI and ESGright.

### Terms and conditions

1. Registration should be completed and paid for no later than one month prior to the programme date.
2. We reserve the right to refuse admission for registrations which remain unpaid one day before the programme date.
3. Receipts will be issued once payments are made.
4. Once a registration is confirmed and paid for, NO CANCELLATIONS will be allowed. If a registrant is unable to attend, a substitute can be made without an administration fee.
5. The onboarding process with GRI Academy starts *6 working days* from the training date. Thus, any changes will result in penalty (for cost of cancellation).
